

Effective July 7, 2003, local Upstate districts and NYC agencies began receiving electronic access to the Office of Administrative Hearings Online Calendar. This access is "Read Only". Updated information with respect to final dispositions after hearing such as Heard, Withdrawn, and Default as well as adjournments can now be obtained in "real time," as the FHIS is updated.

Local district/agency staff can access the Hearing Calendar via the (PFCLD1) option on the Fair Hearing Information System (FHIS) Local District Fair Hearing Menu. The attachment provides instructions for accessing the On-Line Calendar. This is the same data available to Office of Administrative Hearings staff via Selection 26 (PFCLDR) on the Fair Hearing Information System Menu.
