



		Subject: New Job Centers Queens, DeKalb, Linden, and Brownsville (ISC 53, 64, 67, and 73)

Effective March 12, 2001, Income Support Centers 53 (Queens), 64 (DeKalb), 67 (Linden) and 73 (Brownsville) have assumed responsibility from the NYC Office of Employment Services (NOES) for processing employment-related sanctions, in the same manner that the Yorkville (ISC 19), St. Nicholas (ISC 26), Hamilton (ISC 28), East Harlem (ISC 32), Rider (38), Queensboro (ISC 51), Fulton (ISC 61), Coney Island (ISC 63), Bushwick (ISC 66), Bayridge (ISC 70), Euclid (ISC 78), Rockaway (ISC 79), Greenwood (ISC 85), and the Richmond (ISC 99) Job Centers now administer employability-related issues (see OAH Transmittals 01-18, 01-11, 00-20, 00-13, 99-51, 99-22, and 99-08). The Office of Employment Services continues to require notification of hearing requests on employment issues generated by these new Job Centers and should be included as the secondary agency, as follows:

The notices generated from these centers will indicate "Queens," "DeKalb," "Linden," and "Brownsville" in the top left-hand corner of the notice instead of "Office of Employment Services," and the Income Support Center number (53, 64, 67, or 73) will appear in the "IM Center" field. In processing requests pursuant to these notices, Communications Intake Staff can combine non-employment and employment-related issues in one request. You will be advised at such time as additional centers assume responsibility for employment issues. Attached is an updated NYC Income Support/Job Centers listing for your information.
