# INTRODUCTION

This Annual Report is being submitted by OTDA in satisfaction of the requirements of section 17(d) of the Social Services Law and section 164 of the Executive Law.



## MISSION/VISION

### **Mission**

To help vulnerable New Yorkers meet their essential needs and advance economically by providing opportunities for stable employment, housing, and nutrition.

### **Vision**

Empowering New Yorkers to improve their financial security and household stability in support of strong families and communities.





## FAMILY ASSISTANCE PROGRAMS



## NUTRITION ASSISTANCE

The Supplemental Nutrition Assistance Program (SNAP) continues to be a key part of New York State's efforts to address hunger. For an eligible household consisting of a single parent and two children, SNAP can provide up to \$6,060 a year.

An average of 2.7 million people a month received a total of almost \$4.5 billion in SNAP benefits during the past year.

Households can apply for SNAP online through New York State's myBenefits portal, [myBenefits.ny.gov](https://myBenefits.ny.gov) and New York City households can also apply online through the city's ACCESS NYC site: [www.nyc.gov/accessnyc](https://www.nyc.gov/accessnyc).

OTDA continues to support community-based organizations that carry out SNAP outreach to underserved communities, as well as groups that provide nutrition education and obesity prevention services. OTDA and social services districts also provide employment and training services for SNAP recipients to help them secure a job.

## ENERGY ASSISTANCE

The Home Energy Assistance Program (HEAP) helps eligible households cover the cost of heating their homes during the winter. The federally-funded program also offers an emergency benefit for households facing a heat-related emergency.

Last winter, 1.46 million households received a regular HEAP benefit and approximately 117,000 of those households also received an emergency HEAP benefit. This year OTDA allocated more than **\$55 million** of HEAP funding to New York State Energy Research and Development Authority (NYSERDA) and NYS Homes and Community Renewal (HCR) for weatherization activities. Homeowners and renters can apply for weatherization through either agency, and eligible households may receive energy efficiency services as well.

Additionally, households eligible for HEAP can apply for up to \$400 to get their heating equipment inspected and cleaned prior to the start of this winter. OTDA has dedicated \$2 million in HEAP funding to offer the “clean and tune” program.

Households that get their furnace or boiler tuned-up are less likely to face heating emergencies when the colder weather hits. The improved efficiency of the heating equipment can also mean lower energy costs for these households, allowing their HEAP benefits to go further.

OTDA also used \$5.5 million in HEAP funding to provide air conditioners this past summer to eligible low-income New Yorkers with documented medical conditions that are exacerbated by extreme heat. To qualify, applicants had to meet income guidelines and provide written documentation of their medical condition.

## PUBLIC ASSISTANCE

Public Assistance provides temporary cash assistance to eligible families and individuals to help them meet basic needs such as housing. This benefit is essential to those who may be temporarily unemployed or unable to work, as well as very low-wage workers.

Adult Public Assistance applicants and recipients are assessed to determine what activities are most appropriate to help them obtain employment. Individuals may be exempt from engaging in work or work activities based on certain factors outlined in social services law, such as being too ill to work, caring for a child under three months of age or caring for an incapacitated family member.

Those who can work must look for work and/or participate in activities to prepare them for work. These activities include job search, job readiness instruction, adult education and job skills training, or college degree programs.

Each individual is provided support services to enable them to engage in employment-related activities, including needed child care and transportation assistance.

Those unable to work may be expected to engage in medical care or treatment, as needed, to help them improve their overall health and ability to work.

One of the main objectives of OTDA and local departments of social services is to help work-capable Public Assistance recipients enter the workforce. Employment is the most reliable path out of poverty toward self-sufficiency, and reduces the need to provide publicly-funded support for households.

Public Assistance is also available to help low-income households meet emergency needs such as a rental security deposit or to repair a car needed for work.

## CHILD SUPPORT SERVICES

The Child Support program plays a vital role in OTDA's commitment to enhancing child well-being and currently serves 776,000 children in New York State. The program helps families achieve financial stability, reduces child poverty, and encourages parents to be more involved with their children.

Last year, more than \$1.8 billion in child support was distributed on behalf of over 795,000 families. Nearly three-quarters of all child support collections were withheld from employee paychecks, signifying the important role employers play in the success of the program.

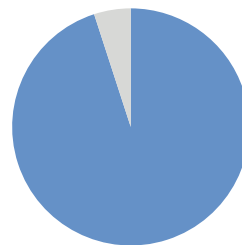
OTDA provides custodial parents of all income levels with assistance in obtaining financial support and health insurance coverage for their children. The program helps by locating noncustodial parents; establishing paternity; establishing, modifying, and enforcing support orders; and collecting and distributing child support payments.

Child support is an important income source for families, including those receiving Public

Assistance, providing them necessary resources to care for their children. Annually, 95 percent of all child support collections are paid directly to families, while 5 percent goes to repaying Public Assistance.

## EMPLOYMENT SERVICES

Those who are working are encouraged to seek any economic supports they are eligible to receive to supplement their income and help meet their needs. OTDA provides funds to social services districts and community-based providers to deliver a range of employment services, including job readiness, job search and placement, and education and job skills training. In addition, OTDA has Jobs Program staff located in several counties that provide direct job placement assistance to help those seeking or receiving Public Assistance to obtain work.

From July 2017 to June 2018, approximately 95,600 Public Assistance recipients each month were engaged in work or work-readiness activities.



## SUMMER YOUTH EMPLOYMENT

More than 18,000 young people from low-income households gained valuable work experience through New York State's Summer Youth Employment Program. OTDA distributed \$40 million to all 57 counties and New York City to help connect youth to jobs and help them acquire skills they can use in school and beyond.

The Summer Youth Employment Program plays an important role in introducing youth into the workforce, helping them acquire skills that can be used to improve performance in school and become responsible adults. Funds are used to subsidize the wages paid to eligible youth, to support education and training activities, as well as counseling and employment-related services, such as transportation to and from work or job training. Participants work in entry-level jobs at places such as parks, nursing homes, summer camps, child care organizations, senior citizen centers and community recreation centers, among others.

The OTDA Summer Youth Employment Program is open to young people ages 14 to 20, whose families have a family income below 200 percent of the federal poverty level, or \$41,560 for a family of three. Participants received at least the hourly New York State minimum wage of \$13 for New York City, \$11 for Nassau, Suffolk and Westchester counties, and \$10.40 for the remainder of the state.

## STATE SUPPLEMENT PROGRAM

The State Supplement Program provides state-funded financial assistance to eligible aged, blind, or disabled individuals and is in addition to the federal monthly benefit paid to most Supplemental Security Income (SSI) recipients.

OTDA began administering the SSI State Supplement Program in October 2014. New York State previously contracted with the Social Security Administration to administer the State Supplement Program. OTDA's State Supplement Program now determines eligibility and authorizes approximately \$50 million in monthly benefits to qualified individuals. These payments help recipients meet housing, food and other necessary living expenses.



## HOMELESS HOUSING

OTDA administers an array of programs to help address homelessness throughout the state. These programs provide a continuum of services for homeless, at-risk and low-income households. They are designed to prevent homelessness, provide shelter for the homeless, construct supportive housing for the homeless and offer essential services to stabilize housing situations and increase levels of self-sufficiency.

During the 2018 funding round, the Homeless Housing and Assistance Program (HHAP) awarded \$61.4 million to 16 projects supporting the creation of 547 HHAP units. In addition, funding was provided for repairs at existing emergency shelters, totaling 34 units and 151 beds.

The New York State Supportive Housing Program provided \$30.1 million in funding to provide essential support services for tenants of permanent and transitional housing programs. This funding supported 18,740 units of housing serving families, single adults and young adults.

The Solutions to End Homelessness Program (STEHP) provides case management and assistance, including eviction prevention services, to households that are experiencing, or are at risk of, homelessness. STEHP provided \$15.8 million in funding last year, which was used to help more than 13,500 individuals access emergency or transitional housing following a housing crisis; transition 6,100 individuals from homelessness to permanent housing through rapid rehousing services; and prevent homelessness for 25,000 individuals experiencing housing instability.

Federal funding through the Housing Opportunities for Persons with AIDS program is primarily used to provide long-term rental subsidies so that people living with HIV/AIDS and their families can access rental housing in their community. Through 11 contracts, services

are provided in 35 counties throughout New York State. The 2018 allocation is \$2.9 million.

The Empire State Supportive Housing Initiative (ESSHI) dedicates state resources to providing service and operating funds for newly developed permanent supportive housing units for homeless individuals with one or more disabling conditions, or other life challenges, and their families. Funds are used for operating expenses to maintain the supportive housing units, to help clients remain stably housed, and to provide case management and other supportive services. While ESSHI is a multi-agency effort, OTDA will contract with 38 awardees supporting 435 new units from the first two rounds of funding. In May 2018, a third request for proposals was released and resulted in 182 conditional awards.

## ASSISTING REFUGEES

OTDA is responsible for implementing services for refugees in New York State. The agency supervises state- and federally-funded programs to achieve this mission.

These programs and services help refugees and their families acclimate to their new life in New York State and achieve economic and social self-sufficiency; help repatriated citizens arrive safely at home; and assure proper foster care for unaccompanied refugee and entrant minors.

## ASSISTING TRAFFICKING VICTIMS

OTDA continues to play an important role in assisting victims of human trafficking in New York State. The Response to Human Trafficking Program provides a coordinated community-based approach and comprehensive case management to address the service needs of trafficking victims.

Critical services are available through local social services districts if victims are eligible, or through six state-funded service providers throughout the state. In 2017, there were 289 individuals referred to New York State, with 273 of them confirmed as victims of trafficking. Victims may need help with shelter, health care, mental health services, legal services and other needs. OTDA also trains government and non-profit workers in identifying human trafficking victims.



## DISABILITY DETERMINATIONS

OTDA is responsible for making medical determinations on disability claims filed with the U.S. Social Security Administration under the Social Security Disability Insurance and/or Supplemental Security Income programs. While there are different financial supports available through these disability programs, the medical eligibility factors considered are the same.

Both programs are administered by Social Security. Individuals who have a disability and meet medical criteria may qualify for benefits under either program. These benefits and administrative costs are 100 percent federally funded.

During the past fiscal year, OTDA's Division of Disability Determinations reviewed more than 219,000 cases. Social Security seeks to expedite processing for claimants with conditions and circumstances that are likely to result in a finding of disability with its Quick Disability Determinations (QDD) workload. The Division ensures that New York's QDD claimants receive the high priority they deserve, which is reflected in its rapid processing times. New York averages only 6.3 days per claim, which significantly exceeds the national average of 20.5 days.

## SHELTER OVERSIGHT

OTDA is responsible for certifying and inspecting publicly funded homeless shelters for families and single adults throughout New York State. This role is essential to ensure residents have a safe and clean place to stay, and that necessary services are provided to help them obtain permanent housing.

There are approximately 750 shelters across the state that provide an array of services, including assessment and case management, access to healthcare and childcare services, and assistance with finding permanent housing. These shelters may be operated by local social service districts directly or through a contracted provider.

In addition, OTDA is also responsible for the development and administration of agency policies in accordance with state regulations that establish the programmatic and physical plant standards for shelters.

Shelters serving fewer than 10 families or fewer than 20 single adults, are not certified by OTDA. However, all publicly-funded shelters in New York State, regardless of certification, are subject to OTDA oversight.

## PROGRAM INTEGRITY



## PROGRAM INTEGRITY

OTDA takes seriously its responsibility to make sure New York's economic assistance program benefits are provided to those truly eligible and in need. OTDA works extensively with local, state, and federal partners to coordinate efforts to uncover, avert, and prosecute fraudulent activities.

To prevent and detect welfare fraud, OTDA oversees local social services districts across New York State. The agency issues program integrity guidance, presents training for fraud investigators, distributes data matches and conducts reviews of local fraud unit operations. Additionally, OTDA works cooperatively with federal and state inspectors general, local social service investigative units, and law enforcement agencies on fraud and trafficking investigations.

OTDA's Public Assistance Reporting Information System (PARIS) match is used to identify clients receiving Public Assistance or Supplemental Nutrition Assistance Program (SNAP) benefits in multiple states. OTDA conducts a wide range of data matches from federal, state, and private information sources to verify specific, high-risk elements of client eligibility, such as earned income. Other data matches are designed to find deceased, disqualified, and incarcerated clients, as well as detect other income and client resources. OTDA performs numerous data analysis projects annually, focusing on SNAP retailer and client trafficking. The agency then works with the New York State Welfare Inspector General, the U.S. Department of Agriculture (USDA), and local districts on the resulting investigations.

Additional OTDA efforts that assist with detecting and prosecuting fraud include:

- The State Law Enforcement Bureau, a cooperative SNAP retailer investigative process that uses OTDA, USDA, and local law enforcement resources to detect and prosecute SNAP retailer trafficking;
- The Fraud Referral web page, which helps collect, process, distribute and monitor citizen fraud and trafficking complaints sent to local investigators;
- The Front End Detection System, which proactively identifies applications requiring further review prior to benefits being approved and issued;
- Eligibility Verification Review and ad hoc data analysis projects to identify active cases for investigation;
- Identifying disqualified SNAP applicants to prevent individuals from receiving benefits while serving a disqualification for program violations; and,
- Training local law enforcement, large retailers and other groups to increase their knowledge of welfare fraud – specifically SNAP client trafficking cases.

## ADMINISTRATIVE HEARINGS



## ADMINISTRATIVE HEARINGS

OTDA is responsible for providing prompt and impartial administrative hearings, and to issue timely and accurate hearing decisions. The office also performs administrative hearings on behalf of other agencies and processed more than 213,000 requests for hearings last year.


OTDA's Office of Administrative Hearings becomes involved when an applicant or recipient believes something is wrong with their case and it cannot be resolved directly with the local social services agency. The Office of Administrative Hearings receives letters, phone calls, faxes, and other types of requests for fair hearings. Staff members work with those seeking a fair hearing to determine the issues to be addressed at the hearing, which is scheduled as rapidly as possible.

The Office of Administrative Hearings issues two notices. The first notice advises an individual that the request for a fair hearing was received. The second notice provides scheduling information. These notices also include an individual's rights regarding the hearing and access to evidence and policy documents.

An administrative hearing is a chance for applicants for, and recipients of, assistance

to tell a hearing officer why a decision by a local social services agency is wrong. OTDA provides an impartial fact finder who listens to all parties, gathers evidence, evaluates credibility, applies the law, and recommends a written decision about the local agency's action. The written decision may order the local agency to amend an individual's case.

Once a decision is issued, the Office of Administrative Hearings works to ensure the local social services agency complies with the decision regardless of the party it favors.



## APPENDIX

This appendix includes data on Fair Hearings covering the period from October 1, 2017, through September 30, 2018.

The tables include the total number of hearings requested and heard, as well as the number of issues requested and heard, for each local social services district. A hearing may review more than one issue.

Also included are hearing outcomes broken down by social services district and program. These tables reflect the number of issues that were affirmed, reversed, withdrawn by the local district, were correct when made, were settled, or “other” (consisting of cases which the Commissioner could not review because of subject matter jurisdiction or the Statute of Limitations, or because the client withdrew the hearing request).

Additionally, there is a summary of formal requests for reconsideration or rehearing of appeals and a summary of court actions on hearing decisions.
